Good morning,

I've tried to grab your questions and separate them out. Your questions are in **bold**, and my responses are in normal font.

To confirm that a Tirz buy by the city would also include logical land value, added to the structural, and whether that was simply an average of structures?

Any purchase of a property would have to be on a mutually agreed upon price by the City and the Property Owner. It is anticipated an appraisal would be needed to help ensure a fair market price, just like if you were selling your home to a private individual.

Something else, that just hit my mind, is that 'just what if' JV, or Mr. Bleess who has mastered it, 'could possibly,' elevate, or reconstruct us, possibly as well as those of our block neighbors who might also wish to stay, and then sell those homes to the Tirz, or the city, who could then simply sell those elevated homes to the developer? Would that be another possible option?

This could be an option. It seems there are a few more logistics we would need to work through but it is something to look into. I think a more likely buyer for a home that is already elevated would be a private buyer rather than a developer, but it would still be an option.

Being in a TIRZ does not preclude you from receiving a home elevation. You would still be eligible for one at some point.

If I missed any questions I apologize. Please let me know and I'll do my best to answer.

Dear City Manager Austin Bleess and Mrs. Lorri Coody,

Anna, and I, enjoyed listening to the meeting, and we heard new information. However, my wife, and I, have some strong emotions about the Tirz, just as our longtime, good, neighbor, Mrs. Freeman did. I was

perusing the city's documents on the Tirz, and we were concerned at the 131,000 figure, and I'm not sure if Councilman Singleton understood what I meant. Mr. Bleess did. We understand now that that is only an average of assessed 'building', or 'structural,' value, and Not the additional 'land' value, per se.

I think the point resonated, for sure to Mr. Singleton, who sounded sympathetic to both my, and my wife's cause, that we've begged for either an elevation, or reconstruction(since I believe we may be out of the floodway, which changed in the last few years), with it possibly being now somewhere in our backyard, or beyond it, for going on five years now.

We still greatly desire either an Fema/city home elevation, Or a Fema/city reconstruction, since we might not want to move right away. Our home is paid off, yet, as we are low income, we still struggle, greatly, each year, with: property taxes; school taxes, property and flood insurance. As Mr. Bleess knows I've expressed, numerous times before, a chief family concern is being able to relocate to a comparable area with whatever we might get.

We Love Jersey Village. We Love the community vibe, police, EMS, fire department, etc. It was myself, City Manager Austin Bleess, Mayor Mitcham(then Councilman); and Councilman Singleton(then council candidate), who were the only people from Jersey Village who went before Harris County Commissioner's Court to beg and ask for the bayou to be widened, which, as you may know from old timers who know JV history, was not done decades ago.

It is ironic to us, now, looking back, in 20/20 perspective, that I was the only one who went, on my own, yet still knew it was the ethical, moral, thing to do, not only for my own family, and our own home, to protect our property and lives, but also for my neighbors and fellow and sisters Villagers. Now, it's a bit bittersweet, since Anna, and I, are glad as we watch the bayou get widened, since we can view it living right on the bayou, but now we face living in the Tirz zone, with its new details.

What I'm trying to say is that we would really still like either a home elevation, or home reconstruction, but that we're not precluding the possibility of not ever selling to you. Something else, that just hit my mind, is that 'just what if' JV, or Mr. Bleess who has mastered it, 'could possibly,' elevate, or reconstruct us, possibly as well as those of our block neighbors who might also wish to stay, and then sell those homes to the Tirz, or the city, who could then simply sell those elevated homes to the developer? Would that be another possible option?

Also there is an expiration date of twenty years to the Tirz, which at first gander alarmed me, but then, once I read and researched more about Texas Tirz zones, and Texas being one of the only states that uses Tirz zones, I discovered that that is sometimes a standard set expiration date. I had raised my hand, in the Tirz meeting, you can explain to Mr. Bleess, since my wife and I wanted to confirm that a Tirz buy by the city would also include logical land value, added to the structural, and whether that was simply an average of structures? I know Mr. Bleess answered and Mr. Singleton may've known the answer, just as well.

We fear flooding, Mr. Blees and Mrs. Coody. We feel blessed that the bayou is finally being cut, as it should be, but we still fear flooding, and our home is paid off, and we fear taxes and wish to protest them, but we still want either a home elevation, or reconstruction(which we might qualify since we may be out of the floodway by now). I saw one floodplain map showing us out of it, which means we may've been moved out of the floodway.

We have many more concerns. My wife's stomach is hurting, and she's feeling very nervous, because

this is our home, which is paid for, and we sympathized with our lovely, decades long, neighbor, Ms. Freeman. We feel its is good, and just, that I tried to speak on behalf of myself, my wife, and our family on this crucial matter. We Love our home. We Love that the bayou is being done. We Love our neighbors. We also intellectually realize that a home is an asset, just like any other. So, in some areas they can drastically decrease in value, due to blight, due to vacant ones, due to natural disaster, even due to catastrophic freezes, and other merciless effects of climate change that doesn't discriminate in its path of wrath and heartlessness.

We have a neighbor, who I shan't name nor list, who is a very strong friend of mine. He has a family, which he Loves dearly, just as well. We were talking, or texting, and he was telling me, that her really still desires a home elevation, or reconstruction, just as my wife, and I, still strongly desire. But he was also looking at the picture of possibly trying to grow his home value, similar to an interest rate that would help a consumer, not hurt them, like say a savings account, or some investment.

Many people view their homes as investments, which they are, simultaneously, along with, likewise, being your own beloved abode, place to sleep, be a family, live your life, and experience a life's memories, good, bad, and neutral. We are humans, who live on land, and in structures, as do our fellows and sisters. We depend upon our abodes on a daily, nightly, 24/7 basis. They are really like our 'most crucial asset,' with likely our vehicles being a firm second place.

What I'm trying to say is we were logically against it, at first, and my wife is still super scared about our taxes, and we struggled to pay them each year, even though we protest them, and regularly lobby Bobby, and others, who'll listen for increases in homestead exemptions. We still desperately want either a home elevation, or a home reconstruction, and we realize that would probably necessitate both FEMA and municipal money, or at least FEMA funds.

We wish that yourseld, Mr. Bleess, and our city leaders, and our city attorney, would work as hard as possible, to make sure that the taxes would not become onerous as a result of the Tirz. We're hoping and praying, along with our neighbor couple who feels as we do, that our home on East Jersey would be added to a future elevations and/or reconstructions round of homes, even if we are in the Tirz, with a future option to exercise to ever sell that then elevated or reconstructed home, back to the city, who, if the Tirz had not yet expired at that future date, might then be able to sell the elevated, or reconstructed, home to the developer, with the city then being able to reap even more savings by possibly not having to pay for demolition.

Then, the city could reduce total turn-around cost, by, essentially, not having to pay to demolish the home, Or our home's demolition could simply be part of a FEMA/city home reconstruction, whereby FEMA might even pay the demolition and reconstruction. Yet, if we were still within the Tirz, and say we go older, then we might be able to one day sell our home, to the city, or Mr. Bleess, who could then sell the home to the developer, or builder, who could then sell it to some new family, per se.

This is simply just a thought, or a 'tweak,' of the current plan, as it exists, which might make many East Jersey owners and residents alot happier, if there were some way to stay on, or for those not ready to leave just yet, who could still be put into upcoming FEMA elevations and/or reconstruction rounds formulated by Mr. Bleess and staff. My wife, and I, feel many of our neighbors' sentiments. It's a split set of a bunch of emotions coming at you all at once, with much to consider.

Many have fully paid off their homes on East Jersey, and it's taken decades, and some don't want to just jump up and move, as others do. My view was that I should be man enough to express my wife's view, that our home is paid off, and this is our most valuable material asset, and we shouldn't be forced to just up

and move, and we hate the thought of bulldozers and excavators, and we pray they have insurance and that they would be as delicate to our aged home as humanly possible, in all ways, shapes, and forms. We have a life here, that we''ve become use to, and we Love our block. We don't want to change everything and up and move immediately, but we don't want to be precluded from selling, either.

We feel that one way, Mr. Bleess, you could defray the cost of demolition, for the city, might just be to apply us for a home reconstruction, which would be our first choice, Or a home elevation if that weren't available, as our second choice. If there were a way for us to sell, and have the Tirz, or the devoloper, rebuild us elevated, that might be a concept, as well. In the future, then, we, and possibly even our neighbors, might then have the option, to exercise, to sell to the city, who could then sell that reconstructed and/or elevated home, to the developer, who'll possibly build the home to county code, anyhow.

As many age on our block, they would have that option to exercise, to sell to the city and you, Mr. Bleess, and the city, in exchange could get a good price, from the builder or developer, and sell that elevated, Or reconstructed home, as is. The home owner could then get a better price from the city, if elevated or reconstructed, and the city could turn around that home, say from somebody who just got old and wanted to move, to the developer or builder at profit.

East Jersey Drive homes, which could easily be FEMA elevated, and where the family, or person, wanted to stay, could be elevated, while those on the block, who weren't ready to exit, say immediately, but also wanted FEMA reconstruction, could be then reconstructed, with both types being put into a future year's mix of BCA, and/or BCR, optimal batch of that year's FY homes sent to FEMA in an application to be approved.

These improved, or flood mitigated in place, East Jersey Drive homes, would then allow the city, itself, to defray the expensive demolition costs, completely, since FEMA would pay it, or the home wouldn't have to be demolished if it was simply elevated. These homes would be good Chess pieces, with which Mr. Bleess could sell, or flip, to the developer, who could then raise the price of sale to the new buyers. And, the people not leaving, immediately, would be greatly pleased, yet still possess the logical exercisable option to be able to leave in future years.

Some couples have simply outgrown their abodes here. Some of them are larger and bare more tax, and maybe their children have already been born, raised, and left their parents homes. Some of us, especially myself, and my strong neighbor friend, want to raise our kids here, are in the process of that, just like Mr. Bleess, and many on council, but when we grow older, all our kids grow up, and move away, we may want the option to be able to leave to the countryside, or move somewhere else. We don't even, remotely, see it that way right now, but of course.

For now, our chief concern is keeping our taxes low, and obtaining either a municipal/FEMA home elevation, Or a FEMA/municipal home reconstruction, in order to lower insurance costs and protect our lives, property, and possessions from flooding, which we've already endured enough of. I'm trying to look at solutions, which might appease both sides of coin on East Jersey, both those who want the TIRZ, as well as those of us who've had logical, pragmatic, questions, yet still might not mind the exercisable option to sell in some future years.

I feel that if the city could forgo the calculated in costs of demolition on some homes, trans via either being sold an already elevated, or already reconstructed, home, that the city, and Mr. Bleess, might then command an even higher, less overhead cost(i.e., minus demolition), to command an even higher price from the developer, or builder, who could then simply turn around and sell those exercised homes, 'without

any cost of: labor; materials; demolition; etc.' This might just be optimal for all parties concerned; home owners; city; builder/developer purchaser; And new buyer.





Good evening Barbie,

Thanks for contacting us regarding the proposed tax increment reinvestment zone along the east side of Jersey Dr. Although TIRZ is a common tool for use in under developed or blighted areas, that is not the sole use. Texas law only requires that city council determine that "development or redevelopment would not occur solely through private investment in the reasonably foreseeable future" in the area.

I also share your concern about government overreach. I don't think that the proposed TIRZ constitutes any form of overreach that would justify the "Big Brother" label. In fact, compared to the red tape and restrictions posed by any FEMA program, a public-private partnership that the TIRZ would make possible would be a far more market driven approach than perpetual government ownership of pockets of vacant land that would result from targeted buyouts.

I agree that the proposed TIRZ is not, nor should it be, the only solution to the problem of flooding in our area. This is why we have continued to pursue home elevation grants (council approved the submission of two applications for nearly 30 homes last night) in addition to the golf course berm, the Wall St. drainage project, and the E127 tributary widening project on the west side of the city. The county is preparing to break ground on the long awaited channel improvements to White Oak Bayou from Hollister to FM 1960 (which will include channel improvements in JV) very soon. Even after all of these other projects are completed, there will still be dozens of homes still at substantial risk of flooding.

If we, as a city council, did not at least explore all possible options to get families out of the floodplain, we would be shirking our responsibility to our citizens. This is why we're not pursuing one solution over another we must take an "all of the above" approach.

Ultimately, this is about creating more choice - not limiting it. Each resident on Jersey Dr. will have the right to choose for themselves how they want to address the fact that their home is at continued risk of flooding. All we are asking the other citizens in the area is to not deny their neighbor one additional alternative choice that could be offered through the use of the TIRZ.

I hope we get a chance to discuss this proposal in more detail very soon, whether tonight at the townhall, or some other time in the near future.
